The Philadelphia Division is pleased to announce that we will be conducting our next meeting on Saturday, June 12th at Saint Alban's Church in Newtown Square, PA. The clinics for this meet will include a presentation by Jim Dalberg on railfanning in the Lehigh Valley area. Many of these slides cover areas Jim has modeled on his extensive home layout. There will be additional clinics presented, but the schedule has not been confirmed at presstime.

The contest for this meeting will be weathered models. That's right; anything you have that is weathered can be brought for this popular vote contest. It can be a structure, locomotive, freight or passenger car, figure, or a tree, whatever! This is a little different twist, so let's see what you bring.

After the meeting, the STARR modular railroad will be conducting an operating session for you to participate in. This extensive layout includes a long mainline run and much local switching. Control is by DCC. Here is a great opportunity to get your feet wet in operations if you haven't done it before, plus the chance to use DCC in an operating session to see the many advantages it offers.

Burned teens sue railroads

Two teenagers who were severely burned by an electrical wire in 2002 while they were on the roof of a parked railroad car near the 700 block of New Holland Avenue are suing Norfolk Southern and Amtrak for damages in excess of \$150,000. The lawsuit, filed earlier this month in U.S. District Court in Philadelphia, claims the accident could have been prevented had there been signs warning the teens of the electricity surging through the catenary wires stretched above the railroad car. Jeffrey Klein and Brett Birdwell, who were both 17 at the time, climbed the Norfolk Southern railroad car parked on Amtrak property on Aug. 10, 2002, to "see what the view looked like from there," according to the civil complaint. Norfolk Southern Railroad spokesman Randy Husband declined to comment on the lawsuit. immediately available for comment.

Klein, of East Stroudsburg, was burned first and collapsed on the railroad car. Birdwell was burned after touching Klein. Klein suffered second- and third-degree burns over 75 percent of his body, including his left ear, neck, shoulders, arms, left hand, back and groin. He was treated at Temple University Hospital, Philadelphia.

Birdwell, of Stroudsburg, was

burned on his face, forearms, wrists, hands and left leg. He was treated at Crozer-Chester Burn Center, Danville.

Lancaster attorney Joseph F.
Roda, who is representing Klein and
Birdwell, wrote in the lawsuit that "if
a sign warning of the danger of
electrical arcing had been posted next
to the ladder that Jeffrey and Brett
climbed, neither boy would have
climbed that ladder."

In the lawsuit, Roda cited a 1986 Federal Railroad Administration report as saying: "Electrical current of catenaries is so great that shocks can result without actual contact with wire: Warning signs along electrified railroads can reduce accidents; Signs provide both symbolic should representation such as a lightning bolt and the warning legend." The railroad tracks are located near Grandview Plaza at East Ross Street New Holland Avenue Trespassing is prohibited on the tracks.

A flash illuminated the sky when Klein was burned. Witnesses called 911 at 10:19 p.m. and firefighters subsequently rescued the teens. Investigators found a skateboard on top of the railroad car near Klein and Birdwell.

One of the problems with being the editor of a newsletter such as The Dispatcher is, no matter what happens it needs to be out and it needs to be out on time. This issue is a little late and a little thin, and I must offer my apologies to all the division's members.

My family suffered the loss of my father Eugene E. Salotti on Sunday, May 2nd. Being involved in making all the necessary arrangements and caring for my mother has left precious little time for any hobby activities, and thus the delay.

Division member Paul Backenstose has prepared the following report on the RPM Meet hosted by the Division in March of this year. If you missed this, you missed one of the best model railroading activities to happen in the Philadelphia Division in quite some time. I hope you won't miss it in the future.

Railroad Prototype Modelers-Valley Forge

Railroad Prototype Modelers-Valley Forge is history and was, by all accounts, a huge success. 174 people attended and brought along 312 high quality models for display. Attendees were from as far away as Portland, Maine and England.

The idea for holding an RPM Meet in the Philadelphia area began in a van returning from an RPM Meet in Pittsburgh in March of 2003. The occupants of the van, Paul Backenstose, Jim

Dalberg, Dick Foley, Bud Kaiser, and Ken McCorry agreed to try holding an RPM Meet and to seek sponsorship from the Philadelphia Division. This sponsorship was approved and Committee was formed. Andy Hart, Val Pistilli, and Steve Salotti joined the five van passengers on the Committee. The next order of business was to decide on a hotel. The Desmond was chosen and turned out to be an excellent choice. Publicity was sent out and we sat back and waited (and waited) for registrations to come in. Registrations were slow in coming in and we had visions of the Division losing money, which certainly wasn't our intent.

Come winter, things started picking with up eventually 122 people preregistering and 52 people registering at the door. This is far more than we expected. Surveys, e mails, letters, and conversations all indicated a high level of praise for our first RPM Meet. Tentative plans call for RPM-Valley Forge to be held every other year.

That's what I like about DCC-simplicity: as Win Gross, expert extraordinaire, says, or at least I think I heard him say, "...only two wires, but one should be red...".

Several Divisionnaires attended the recent joint MCR-MER Regional Convention in Pittsburgh. There were over 80 from various parts of the MER. There were a number of good clinics, several tours and some interesting layouts to visit, all of which made it very enjoyable.


